GIVING FAMILIES A VOICE - FAMILY GROUP CONFERENCES AND THEIR APPLICATION IN YOUTH JUSTICE SETTINGS

This workshop will consider the use of Family Group Conferencing (FGC) in the context of young people who are involved in, or at risk of involvement in criminal activity. Participants will have the opportunity to hear about the FGC model and how it has been used in Youth Justice settings in the UK and internationally. We will explore the challenges of working with young people who offend, their families and the victims of offending behaviour and how the FGC process is able to effectively balance the needs of all participants to reach a restorative conclusion. We will also consider some direct practice examples and there will be opportunity for participants to explore the issues involved in these.

David Johnston OBE MP

MINISTER FOR CHILDREN, FAMILIES AND WELLBEING David Johnston was appointed Parliamentary Under Secretary of State at the Department for Education on 31 August 2023. He was previously Chief Executive of the Social Mobility Foundation, a charity which runs a range of programmes that incorporate mentoring, internships, university application support and skills development to help young people from low-income backgrounds enter universities and professions.

In addition to being a governor at Pimlico Academy, David is a governor of a sixth form college in London and is on the board of an organisation for 11 to 16 year olds in Oxfordshire.



Dame Rachel de Souza

CHILDREN'S COMISSIONER FOR ENGLAND

Dame Rachel is a nationally recognised educator and advocate for improving the life chances of disadvantaged children. Before her appointment as Children's Commissioner, she founded and led the Inspiration Trust, a family of fourteen schools in East Anglia. The Trust was twice ranked as the nation's top group of comprehensive schools based on pupil progress at GCSE. She was made a Dame in 2014 for services to education.

Dame Rachel was appointed Children's Commissioner for England in 2021. In the role, Dame Rachel conducted the largest-ever survey of children 'The Big Ask' with over halfa-million responses on the issues that were most important to children post-pandemic.



Helen Hayes MP

SHADOW MINISTER FOR CHILDREN AND EARLY YEARS Helen Hayes is the Labour MP for Dulwich and West Norwood, first elected in 2015. Helen currently serves as the Shadow Minister for Children and Early Years focusing on childcare, support for children with special educational needs and disability, and children's social care. Before entering Parliament, Helen was a town planner for twenty years, working with communities to deliver new jobs and homes, and a councillor in Southwark from 2010 to 2016. Helen was previously a member of the Housing, Communities and Local Government Select Committee and the Environmental Audit Committee.
