# Reaching the final sample

# 1. Methodology

## 1.1 Sampling method and recruitment process

The survey employed an expedited sampling approach, referred to as the ASAP method, to gather responses from the target demographic as quickly as possible. To ensure a diverse and representative sample, harder-to-reach quotas were strategically targeted at specific times during the fieldwork period. Recruitment was treated differently across the 13–17-year-old age range, specifically:

- 1. **16-17-year-olds**: This group was approached through two channels:
  - Direct targeting (50%)
  - o Recruitment through parents (50%)
- 2. **13–15-year-olds**: This younger group was targeted exclusively through parents, ensuring appropriate consent and safeguarding measures were in place.

To maintain data quality and relevance, respondents were pre-screened with qualifying questions on individual panel platforms before entering the main survey. This pre-screening process verified key criteria such as age and residence in England or Wales, ensuring that only eligible participants proceeded to the full survey.

#### 1.2 Fieldwork dates

The survey fieldwork was conducted over a six-week period, commencing on Friday, 16 May 2025, and concluding on Wednesday, 2 July 2025. The fieldwork period was extended from the original schedule to facilitate further recruitment from specific sub-groups — namely respondents who are Black, located in London, and classified as C2DE socio-economic status (SES) based on the household's highest earner's occupational grade. This extension was necessary to meet the required quotas and ensure a fully representative sample. Additionally, Savanta transitioned to new research panels partway through the project, as the two panels previously used for the tracker were no longer available. This change necessitated additional data quality checks, contributing further to the timeline.

# 1.3 Survey platforms used

To achieve a broad sample across target demographics, the survey used multiple platforms. This was necessary given the large sample size required.



The primary data collection was conducted through Savanta's 'DIY' platforms, including:

- Cint
- Lucid
- Audience Align
- Catalyse Research
- Probity
- Rakuten
- PureSpectrum
- Samplify
- Digital Age

The use of multiple platforms had several advantages:

- 1. It allowed us to access a larger pool of potential respondents.
- 2. As the fieldwork progressed, additional panels were added to meet the large sample size and hard quotas as per requirements.
- 3. This approach helped mitigate the risk of any single platform "bottoming out" or exhausting its respondent pool.

To maintain sample integrity and relevance across all platforms:

- All panels followed the same pre-qualifying process.
- Only respondents meeting the specified criteria for age, gender, region, and SES were directed to the survey.
- Consistency in pre-screening aimed to ensure comparability.

# 1.4 Platform dependency, design effects and exhaustion

While specific data on platform dependency and individual design effects are not available, several measures were taken to minimise potential biases:

- The multi-platform approach inherently reduces dependency on any single source.
- Quota sampling was employed across platforms to ensure demographic representativeness.
- The large overall sample size helps to mitigate potential design effects from individual platforms.

The large sample size did lead to a degree of platform exhaustion:

- Some platforms began to approach their limits of available respondents.
- This included both completed surveys and "quota outs" (potential respondents who couldn't access the survey due to filled quotas).



# 2. Response rates

# 2.1 Survey starts and completions

The survey attracted a total of 34,800 initiations. This figure includes all attempts, including those flagged by Relevant ID checks (which typically identify blocked duplicate IDs and potential bot attempts). The difference between total initiations and valid starts (5,661) shows the importance of Relevant ID checks in maintaining data quality. After excluding these flagged attempts, we recorded 29,139 valid survey starts. This number encompasses completed surveys, archived responses, screen-outs, quota-outs, in-progress attempts, and those who entered the survey but didn't proceed past the standard Savanta introduction page.

Out of these valid starts, the survey achieved a final sample of 10,835 completed responses. It's important to note that this figure represents the final sample after all exclusions were applied, not just the initial number of completed surveys. In-terms of how this final sample number was arrived at:

- 1. Total initiations: 34,800
- 2. Exclusions and dropouts
  - a) Bot attempts (relevant ID fails): 5,661
  - b) Other dropouts and exclusions: 18,340. This category includes:
    - Those who entered but didn't proceed past the introduction page
    - Screen-outs based on eligibility criteria (e.g. respondents from outside England and Wales).
    - Quota-outs (dropped because sufficient numbers had already be required from a given demographic quota)
    - Dropouts at various stages of the survey,
    - Exclusions due to quality control measures (e.g., speeders, flatliners, etc.)

The original target sample size for the project was 10,000. Recruitment was subsequently extended to boost representation among low SES, Black, and London backgrounds, resulting in a final sample of 10,835. In addition, extra completes were collected beyond the original deadline to ensure coverage of hard-to-fill quotas and to maintain data quality following post-fieldwork removals. This led to overcollection after removals were applied.

# 2.2 Dropout rates

Of the total starts, 140 respondents entered the landing page but did not proceed further into the survey. This initial dropout may be attributed to factors such as lack of interest, time constraints, or technical issues. Throughout the remainder of the survey, a total of 2,520 dropouts were further recorded at various points.



## 2.3 Comparison to industry standards

The numbers we've seen in this survey, particularly regarding total initiations, valid starts, and bot attempts, might appear large at first glance. However, it's important to contextualise these figures within current industry trends:

- 1. **Bot attempts**: The high number of relevant ID fails (5,661) is in line with, or even lower than, what many surveys are experiencing today. Bot attempts have become increasingly common in online surveys, especially those with incentives. Recent industry reports suggest that bot attempts can account for 5-20% of total survey initiations, and in some cases this goes up to 75%. The rate of about 16.27% (5,661 out of 34,800) for this survey falls within this expected range.
- 2. **Completion rate**: The completion rate of 37.19% (10,835 completed out of 29,135 valid starts) we consider reasonable<sup>2</sup> for a survey targeting a specific age group (13–17-year-olds). Youth surveys often have lower completion rates due to shorter attention spans and the need for parental consent in some cases.
- 3. **Data quality measures**: The rigorous exclusion process we employed, resulting in 4,109 removals, reflects a strong commitment to data quality. While this may seem high, it's increasingly common in high-stakes surveys to prioritise quality over quantity. Many reputable survey providers report excluding 10-45% of completed responses due to quality issues.

It's worth noting that the landscape of online surveys has changed in recent years:

- The proliferation of sophisticated bots has made stringent identity verification crucial.
- Increased survey saturation among certain demographics has led to lower overall response rates, making these figures quite reasonable.
- The emphasis on data quality over sheer volume of responses has become a best practice, aligning with this approach.

While the numbers in this survey might seem high in absolute terms, they are in line with current industry standards, particularly considering:

- The specific age group targeted (13–17-year-olds)
- The geographical constraints (England and Wales)
- The length and complexity of the survey
- The current challenges in the online survey industry, particularly regarding bot attempts.




Figure 4.1. Number of exits from the survey per question, in the order they appeared



## 2.4 Response rates over time

The chart below illustrates the daily response rates throughout the fieldwork period. It's important to note that the interpretation of this data is complex due to the multi-stage and multi-platform nature of the sampling design. The bursts of activity seen in the figure are likely attributed to specific actions taken during the sampling process, such as advertising the study on a new platform or opening up additional sample groups.

# 3. Data cleaning and processing

#### 3.1 Exclusion criteria

Two primary methods were employed to identify potentially unreliable responses: speeder detection and flatliner identification.

- Speeders were flagged using a sophisticated system that calculated the average response time for each question as well as the overall completion time for the survey. Respondents who answered an unusually high number of questions too quickly, or whose overall completion time was significantly below the expected duration, were identified as potential speeders. This approach helps to exclude responses that may not have been given due consideration, thereby enhancing the reliability of the dataset.
- 2. Flatliners were identified through a systematic check of individual responses, particularly focusing on carousel questions. The system analysed response patterns to detect respondents who consistently selected the same extreme option (e.g., "strongly disagree") across multiple carousel questions. This behaviour often indicates a lack of engagement with the survey content, potentially compromising the validity of the responses.

## 3.2 Responses removed

Following the application of these exclusion criteria and additional quality checks, a total of 4,109 responses were removed from the final dataset. There were several reasons for removal. Responses were excluded for poor or meaningless replies to open-ended answers (*Other, please specify* answer options, final comments), which suggest a lack of genuine engagement or potential automated responses. Entries flagged as bots or duplicates were also removed to prevent artificial inflation of response numbers. Responses exhibiting flatlining behaviour across questions, as well as those identified as speeders, were excluded based on the criteria described earlier.

Furthermore, responses containing suspicious answers, such as age inconsistencies, were checked and removed on a case-by-case basis. An age trap question, asking for the respondent's birth year at the end of the survey, was used to verify the initially provided age information. Responses failing this age trap were subsequently removed.



# 4. Survey completion details

## 4.1 Survey completion time

The median completion time for the survey was 14 minutes – comparable to the average response length to last year's CVV survey.

#### 4.2 Devices

The majority of respondents - 8,460 in total (78%) - completed the survey using mobile devices. This overwhelming preference for mobile underscores the importance of ensuring mobile-friendly survey design for future studies targeting this age group. Desktop computers were the second most popular choice, with 2,171 respondents (20%) using this method. Tablets were used by a minority of participants, with 204 completions (2%).

# 5. Analysis

#### 5.1 Software

For the generation of data tables and initial analysis, Merlin software was used.

#### 5.2 Statistical tests

To test for statistical significance, two primary tests were applied. For percentage-based data, z-tests were conducted. These tests are particularly useful for comparing proportions between different groups or against a hypothesised value. For questions that yielded numerical data or scales, t-tests were applied to compare means. This approach allowed for the assessment of significant differences between average scores or ratings across different demographic groups or in comparison to benchmark figures. For both, significance was assessed at the 95% level.



# **Quotas and weighting**

#### **Quotas**

Consistent with the approach adopted last year (see last year's technical report <u>here</u>), quotas were used to recruit fixed numbers of participants from key demographic groups. This was to ensure the final sample accurately represents the population of 13–17-year-olds in England and Wales. Quotas were set for:

- Single year of age
- Gender
- Broach ethnic group (e.g. Black, White, Asian etc.)
- Region (e.g. London, North East, South West, Wales etc.)
- Socio-economic group (SEG) divided into two broad SEG groups based on parent's profession

The quotas were set using relevant data from Census 2021.

## **Weighting aims**

Although quotas were used, poststratification weights are also included to ensure the final results are as close to representative of the whole 13-17-year-old population of England and Wales as possible. In last year's survey, we used a Random Iterative Method (RIM) weighting to calculate the poststratification weights for the whole dataset (see last year's technical report here). These weights were designed to match known population characteristics across age, gender, ethnicity, region, and socio-economic group. We employed marginal instead of cross-sectional weighting which meant that each demographic variable was weighted to match its overall population distribution independently. The alternative is to use interlocked quotas or weights, such as weighting for age within gender within region.

The main strength of the RIM approach is that it is easily replicable. In 2024, the weight variable had a mean of 1.01, a standard deviation of 0.35, and a range of 0.02-3.68. Applying the same methodology to this year's data, the weight variable appeared even slightly better: mean of 1.00, standard deviation of 0.18, and a range of 0.06-2.66. This implies that the overall distribution of the population characteristics was more closely met in the 2025 wave compared to the 2024 wave. For this year's survey, we wanted to go beyond last year's approach and apply interlocking weights. The goal of these is to provide more reliable results, when broken down by detailed sub-population.

# **Solutions explored**

In an ideal scenario we would be able to apply cross-weights across all key demographic characteristics (age, gender, ethnic group, region, SEG). However, whilst our sample is large in absolute terms, the number of children that have some specific combinations of characteristics (e.g. aged 13, male, Black, from Wales and a higher socio-economic group) may be very small. This means that if fully interlocking weights were applied to such groups, a small number of observations would be allowed to have disproportionate influence on the results due to a large increase in the variance of the estimates. In other words, this would mean that small changes in the underlying data could lead to considerable changes in the results.



We worked on an iterative basis with survey consultants from University College London (Dr Krisztián Pósch and Ana Cristancho) to test multiple different combinations of weighting factors with the goal of finding a sustainable weighting procedure that could provide the closest match to population estimates and, simultaneously, the highest degree of stability year-on-year. This stability aspect was tested by applying each weighting strategy to both the 2024 and 2025 waves of the CVV, thus considering how the weights would have changed had they been used for last year's survey.

The weighting approach used iterative proportional fitting ('raking') supported by a latent support vector machine (LSVM) to ensure that the weights are not limited by functional forms imposed upon the data. However, further diagnostics revealed that the weights produced this way were very similar to what one would get with relying on iterative proportional fitting alone (with the correlation coefficient r=0.96+) and thus, for easier replicability and quicker computing time, traditional raking was used on its own. For the population estimates we relied on the non-age-adjusted 2021 Census.

The final set of solutions tested are listed below.

- Solution 1 (S1) Same approach as last year, with no interlocking weights for Age, Gender, Ethnicity, Region, and SEG.
- Solution 2 (S2): Age x Gender x Ethnicity (interlocking), Region and SEG non-interlocking
- Solution 3 (S3): Age x Gender x Ethnicity (interlocking), Ethnicity x SEG [divided into two classes] (interlocking), Region (not interlocking)
- Solution 4 (S4): Age x Gender x Ethnicity (interlocking), Ethnicity x SEG [divided into three classes] (interlocking), Region (not interlocking)
- Solution 5 (S5): Age x Gender x Ethnicity (interlocking), Ethnicity x SEG [divided into two classes] (interlocking), Ethnicity x Region (interlocking)

A longer list of solutions were tested throughout the development of the weighting strategy, however, these represent the final and workably complex set that were tested on both waves of the CVV (2024 and 2025). As we wanted to make comparisons between this year's and last year's results, it is important that we updated last year's results to incorporate any revisions to the weighting methodology. The results are presented below.

Solution 3 represents the final solution that we've selected to use to weight the survey results it includes:

• Interlocking weights for Age, Gender and Ethnicity



- Interlocking weights for Ethnicity and SEG
- An overarching non-interlocking weight on region.

Neither of the other more complex versions of the weighs tested (\$4 and \$5\$) converged on a consistent solution, with large variations in the weights between the 2024 and 2025 datasets. As demonstrated in the above tables (Table 1 and Table 2), the solution 3 is likely to be able to provide the highest precision without extreme weights that could potentially emerge due to differences in sample composition. By contrast, solution 4 and solution 5 not only have larger range for the weights but also appear to be prone to sizable changes year-on-year which implies weights being sensitive to sample characteristics.

The range in the value of the weights for solution 3 (0.03–8.08) represents the smallest and largest weights applied. The standard deviation speaks to the distribution of the weights with smaller values suggesting less dispersed weights and thus, fewer weights with very small or very large values. High numbers of large weights are undesirable as it means the weights are having an extreme impact on the results with some potentially small number of respondents with certain sets of characteristics having an outsized impact on the results. The range for solution 3, although somewhat large, is broadly in line with those generated in other well-respected high-quality surveys, as presented in the table below, and with standard deviations on the lower end compared to these.

# Non-response weights

Non-response weights can also be included, in an attempt to adjust for the non-random reasons why someone took part in the survey. During the development of the weighting strategy, two versions of non-response weights were tested:

- Version 1 Incorporating information on the week of data collection, the browser and device used, the specific survey panel they were recruited from, and the reason they were not part of the final survey batch (screened out, quotaed out, or never finished the survey).
- Version 2 Including all of the above as well as their age, i.e. whether they were 13-17 years old or older. This is a so-called 'calibration variable' which is common in quota surveys where we have the basic information on each participant which could be used to calibrate the non-response weight often yielding smaller weights.

Modelling indicated that panel membership had the strongest influence on the weights, with secondary impacts of why they were excluded, and smaller impacts for device used and the week of data collection. Ultimately, non-response weights were not included in the final full set of weights. Give the already large range in the weights being used, including these would have made the final weights excessively large.



# **Final weights**

We remain confident that the final set of weights provide unbiased, stable, and consistent estimates of the total national prevalence figures, derived from this survey. The introduction of specific interlocking weights should provide for more reliable estimates for particular sub-population characteristics, particularly ethnic background. Due to the smaller sample sizes for particular sub-populations within regions, we were not able to include interlocking weights at this level. This means we should be more cautious about the generalisability of the findings presented at the regional level.

The characteristics of the final sample are presented below, before and after weighting, on the latest CVV 2025 data.
